- The gala sealed quotations have to be submitted at this Institute along with the supporting documents:

 1) Pan Card, 2) IT Return of the Last Year, 3) GST Registration Certificate, 4) Trade License
- Each bidder shall submit only one price quotation as per unit.
- Name of the supply work should be super scribed on the sealed cover of the quotation.
- Commencement of submission of quotation paper is effect from today i.e., 06.08.2025.
- Last date/date of closing for submission of quotation paper is 01.09.2025 sharp on before 02:00 P.M.
- Date of opening of sealed quotation papers is **01.09.2025 sharp at 03:30 P.M.** in the Office Chamber of the undersigned.
- The intending bidders or their representative may be present during the time of opening of bid documents at the specified place said earlier.
