- 1) External Final Teaching Evaluation Programme will be held in the above selected primary school and you all are instructed to present on the given day positively within 09.30 A.M. without fail.
- 2) Four Final Lesson Notes on four subject areas (i.e, Language-1, Language-2, Mathematics & Environmental Science) within the periphery of primary education (Class-I to Class-IV) are to be assessed.
- 3) Classroom-demonstration on any two out of four subject areas/four lessons, planned and submitted for final evaluation, one of which must be on language, will be evaluated by means of live teaching demonstrations in that primary School.
- 4) The full marks for Lesson Notes as part of the evaluation is 30 (4 X 7 ½).
- 5) The full marks for classroom demonstration is 50 (2 X 25).
- 6) 20 (Twenty) marks are given on the assessment of the evidences/reports of any two the following 'Other Internship Activities' performed during the School Internship including Practice Teaching (2 X 10). The report should have the following parts (i) Introduction, (ii) Description of the scheme of Organization, (iii) Execution of the activity, (iv) Process of collection of data/evidences, (v) Uniqueness/Innovation in the Activity, (vi) Observations of the studentteacher.
- 7) The following five point rating scale will be used for evaluation:
 - 1. Excellent, 2. Very Good, 3. Good, 4. Average, 5. Below Average
 - Excellent = 90% and above
 - Very Good = 80% to less than 90%
 - Good = 65% to less than 80%
 - Averages = 50% to less than 65%
 - Below Average = 0% to less than 50%
